Proposed Zoning Changes Cause for Concern

Under a new proposed zoning change in the Town of Tyre, agriculture is not allowed along Route 318 from just east of the new apartment complex to Route 89. If you drive by, you'll notice the entire stretch is almost all fields. Another troubling provision includes that all farmers must hide all equipment from view and cannot store anything outside. They are also placing severe restrictions on home-based businesses. Seneca County Farm Bureau asked the Department of Agriculture and Markets to take a look, resulting in four pages of objections submitted to the Town Board for consideration. *Please watch the Town of Tyre website for public hearings and be sure to attend to voice your opinion.* You do not need to be a Tyre resident.

There are also restrictive zoning proposals that will make it impossible to farm in the Town of Ulysses which borders Covert. They will need our support at public hearings. The Department of Agriculture and Markets can help, but we need to speak up now before these laws are passed. Once passed, it could take up to two years to undo these onerous restrictions. *Please attend the public hearings* and talk to everyone you know to educate them on the need to prevent restrictive laws from being passed.

Seneca County Building Codes and NYS Building, Fire and Energy Codes

After many issues with building codes, we reconvened the county Farm Bureau Public Policy Committee to put forth a solution. Concerns ranged from a building codes officer trying to force a farm to bring their maintenance shop up to code to placing a stop work order on a chicken hatchery stating it was a commercial manufacturing facility. The committee consisted of former State Senator Michael Nozzolio, Kelsey DeCloux of Westwind Farm, Tom Murray of Muranda Cheese, Craig Partee of Fleur de Lis Brewery, engineer Steve Messmer of Lively Run Dairy, Jason McCormick, a public engineer, SCFB President Ann Marie Heizmann of Meadeville Farm and assistance from Town of Fayette Supervisor Cindy Lorenzetti. The committee quickly

realized there were two issues: the Seneca County Codes Department and the current edition of the NYS Building, Fire and Energy Code.

SCFB worked with Seneca County to address the issue there and the County Board of Supervisors agreed to hire a Director of Public Works that is a public engineer to provide more oversight and guidance to codes officers. SCFB will continue to monitor this to see how it works.

The current NYS Building, Fire and Energy Code removed the grandfather clause, requiring any change of use for a current building to be brought up to current code. Were you thinking of turning an equipment shed into a farm stand? The cost to bring it up to NYS Building, Fire and Energy Code will likely make it cost prohibitive. Most of the issues lie in the energy code that requires insulation levels, certain ceiling heights, lighting and more. Steve and Jason did extensive research allowing the committee to propose new policy at SCFB's annual meeting. After discussion and revisions, new policy was passed supporting the committee's recommendation. This then became NYFB policy at the State Annual Meeting in December. The new policy reads:

"Agricultural Buildings are defined as places of employment or public access affiliated with the direct production, treating, processing, packing, or public sale of agricultural products where the maximum occupant load of said agricultural building is restricted to less than 50 persons, even if the allowable design load is greater."
