Policy Development 101 By Field Advisor Kim Trombly

New York Farm Bureau has a policy book that we use when we lobby in Albany and Washington, D.C. It is this policy book that we used to pass things like the 2% tax cap on agriculture assessments, the increased estate tax exemption and restrictions on FOIL requests. However, many members wonder how we set these policies. Is it big feed companies? Is it New York City financial advisors? The answer is no. Our policies are set by our regular farmer members and only our farmer members. Each year county Farm Bureaus are asked to identify policies that are important to their farmer members. Once those policies are identified, they are brought to the County Annual Meeting where Saratoga County Farm Bureau members vote to either approve or not approve the new policy. After Saratoga County Farm Bureau approves its

new policies, they are brought to the State Annual Meeting where they are again voted on to determine if they will go into the state policy book. In order for your voice to be heard, you must bring your ideas for Saratoga County Farm Bureau's policies to the attention of the county Farm Bureau board. Saratoga County Farm Bureau is very interested to know what is important to its members, so please email, call, text or talk to a board member. They also encourage you to bring policies to the County Annual Meeting in early October where Saratoga County Farm Bureau will finalize its policies to bring to the state.
