<u>Updates and More</u> Lindsay Wickham, Area Field Supervisor

We finally have a state budget, and just a few days late. The great news is that agriculture really hit a home run this year. All of the usual agricultural programs were fully funded at last year's level. Agricultural education programs, including Agriculture in the Classroom, FFA, and the NY Association of Ag Educators all saw significant increases in their budgets, continuing an upward trend. Also, with the new CAFO permits, there is \$50 million for manure storage construction in the budget.

Now that budget season is wrapped up in New York, we will be working on other issues going through the state legislature, and also Congress. Don't forget about our easy-to-use e-lobby site on our website, www.nyfb.org. It is a big black box in the upper right hand corner. It is of vital importance that our members speak up and touch base with their legislators or representatives. It literally takes but a few minutes to generate a letter to any of these folks. It does make a difference, as we see every year when thousands of letters go to our elected officials. We are strong as an organization, but even stronger when our members participate.

For those of you that did not attend the "Show Me The Money" agriculture tax workshop, you missed a great one. The primary speaker, Bob Wright of the NYS Department of Taxation and Finance, really dug into both ag assessment and the Farmer's School Property Tax Credit. It was truly outstanding. I followed up with information on the many other tax abatement programs for farms, including sales and fuel tax exemptions, farm structures, and others. If you ever need info on any of these programs, they are located on our website, www.nyfb.org, or send me a note and I will get them to you. It was probably the best agriculture tax workshop I have ever been to.

Along those lines, keep your eyes out for those informational sessions, put on by CCE, Farm Bureau, Soil and Water and/or the Agriculture Task Force. All four entities are working hard to get information out to you on all kinds of things, whether it is taxes, how to grow or market products, generational transfer, and many other subjects. Farm Bureau's Ag Task Force is made up of farmers, CCE, Soil and Water, county government, economic development specialists, and other agencies working for the betterment and expansion of Broome County's number one industry. It is truly a remarkable committee and partnership.

Cornell Cooperative Extension of Broome County has been working extensively with five schools within Broome and Tioga counties to bring the Agriculture in the Classroom program. My name is Sarah Atwood, and I am Broome County's first Agriculture in the Classroom educator. I hold a New York State Early Childhood/ Childhood Elementary School Teaching degree. I was born and raised on a larger scale horse boarding and training facility. I have a passion for agriculture and teaching!

This Agriculture in the Classroom pilot program funded through Senator Akshar's office which includes: Maine Endwell, Union Endicott, Windsor, Harpursville, and Owego Apalachin Schools. Each district has 14 units to use for each month, which includes but is not limited to lessons and animal visits. As of April 5, these schools have had lessons about animal adaptations, calf/making butter lessons, bees, nutrition, population and the National Agricultural Literacy book reading of Grapes. I have seen and exposed roughly 3,500 students to agriculture.

A special thank you to Broome County Farm Bureau for donating the Agricultural Literacy Books and specifically Judi Whittaker for all your help and information.
