New Rules For Fruit Tree Depreciation

On December 18, 2015, President Obama signed the Protecting Americans from Tax Hikes (PATH) Act. One of the main provisions that the agricultural community was keeping an eye on was bonus depreciation. Bonus depreciation has permitted farmers in the past to immediately depreciate 50% of farm property placed into service. In addition to having the traditional bonus depreciation extended for an additional five years, Congressman Tom Rooney of Florida drafted language that now permits farmers to immediately depreciate the costs of planting new trees. Prior to this, farmers were unable to depreciate trees until they were used in production. The main motivating factor for Congressman Rooney was to assist Florida's citrus industry that has been hampered with citrus greening disease for several years, leading to over 130,000 of abandoned commercial citrus growers. However, the added legislation will benefit more than just citrus growers. In particular, the New York State apple and grape industries will find Congressman Rooney's legislation tremendously beneficial.

The New Bonus Depreciation:

Any specified plant that is planted or grafted after December 31, 2015 in the ordinary course of a taxpayer's farming business may receive a 50% depreciation deduction of the adjusted basis of the specified plant for the year in which the specified plant is planted or grafted. This amount is phased down to 40% in 2018 and 30% for 2019. A farming business is defined as "the trade or business of farming" and includes "operating a nursery or sod farm, or the raising or harvesting of trees bearing fruit, nuts, or other crops, or ornamental trees. . . . [However,] an evergreen tree which is more than 6 years old at the time severed from the roots shall not be treated as an ornamental tree." Specified plants are defined as (1) "any tree or vine which bears fruits or nuts, and (2) any other plant which will have more than one yield of fruits or nuts and which generally has a preproductive period of more than 2 years from the time of planting or grafting to the time at which such plant begins bearing fruits or nuts." However, nothing planted or grafted outside of the United States qualifies for this new provision.

Orleans County Farm Bureau Offers Scholarships

Orleans County Farm Bureau is awarding two scholarships to qualified graduating seniors in Orleans County. First place will be awarded a \$1,500 scholarship and the second place applicant will receive a \$1,000 scholarship. These awards will go to a student member or to the son or daughter of a regular or associate member of Orleans County Farm Bureau.

Eligibility consists of students that will be continuing their education beyond high school into an agriculturally related field, two-year or four-year program. Or the student applying must be entering into the agriculture industry and should have a completed budget for one year.

The forms must be returned to the Farm Bureau office no later than May 1, 2017. The award decision will be based on scholastic achievements, extracurricular activities, an essay contest and interest in agricultural or agricultural-related fields.

The award will be given in two segments: The first half will be awarded in June, 2017 and the second half at the successful completion of the first semester. Grades must be sent to the Orleans County Farm Bureau office for evaluation. The student shall obtain a GPA of 2.5 or higher to receive the remainder of the award. Or the student will receive the funds once a financial plan for the students agriculture business or how the student plans to better the family farm is presented to the scholarship committee.
