EPA and Army Corps Move to Withdraw Flawed WOTUS Rule

EPA Administrator Scott Pruitt has signed paperwork to review and revise the definition of “waters of the United States” (WOTUS).

Farm Bureau has been outspoken with its concerns on this rule, launching the “ditch the rule” campaign in 2014 to help educate farmers, landowners, and the public on how broad the rule had been written.

If the withdrawal is made final after a 30 day comment period, EPA and the Army Corps would continue to interpret the Clean Water Act (CWA) as they have since WOTUS was stayed by the 6th circuit Court of Appeals in October 2015. However, the situation could become muddled if environmental groups challenge the withdrawal in court.

This is a great step in providing our farmers with clarity and NYFB will be sure to keep you informed as this process continues.

11th Hour Reprieve For Local Farmers? Or Postponing The Inevitable?

Area farmers, 125 employees, and local businesses let out a big sigh of relief as Upstate Niagara Cooperative made a last-minute deal with Kraft/Heinz to buy the plant in Cambell, New York. The plant will stay open and operate preserving 125 jobs with the plan to add 25 more. While this is great news for the employees and the economy surrounding them and the community, it still leaves a lot of uncertainty with the dairy farmers who currently ship their milk there. Approximately two million pounds of milk per day is shipped from local farms to the Cambell plant. The question remains as to whether Upstate Niagara Cooperative will continue the relationship that the plant currently has with the area dairies or they will bring in milk from other areas from members of the cooperative. Time will tell.

MEMBERSHIP
