# Notice of Tompkins County Farm Bureau **2018 Proposed By-Law Changes**

### Article I

Section 1. Members. Only persons and partnerships, unincorporated associations, and corporations organized for agricultural purposes, actively engaged in the business of producing agricultural products, including leasees and tenants of land used for such production, leasors and landlords who receive as rent, either in-kind or cash, all or part of the crop raised on the leased or rented premises, are eligible for membership in this County Farm Bureau, and may make an application to become a member, and, if accepted by the board of directors, they shall, upon execution of the membership agreement, be entitled the rights and privileges of membership.

Section 2. Associate Members. Other persons, partnerships, unincorporated associations, and corporations, interested in agriculture may make application to become an associate member, and if accepted, they shall, upon execution of the membership agreement, be entitled to all rights and privileges of associate membership. Associate members shall not receive the right to vote or hold office.

Section 7. Membership in Good Standing. A member of this corporation shall be deemed in good standing if his their membership fee has been paid for the current year.

### **Article II: Meetings**

Section 2. Notice. Notice of meetings of members and of all matters concerning this corporation shall be deemed to have been duly given if notice therof in writing has been sent by e-mail when correct e-mail addresses are known, or placed in the mail, postage prepaid, addressed to the last known post office address of the member, or, if notice therof has been printed in official publication of this corporation or the official publication of the New York Farm Bureau circulated among its members in good standing. Notice of meetings shall be given not less than ten or more than forty days previous to such meeting.

Section 5. Presiding Officer. The president shall preside at all meetings of the members of this corporation. In his their absence the next office in due order who may be present shall preside and for such purpose the order of officers shall be as follows: President, vice-president, secretary, and treasurer.

Section 7. Township or Community Organizations. Members in each township or in each community that may be duly designated and authorized as hereinafter provided, may form a local organization or group to strengthen the work of this County Farm Bureau. Such township, or community organization, may elect officers and adopt such rules as are deemed necessary for suitable conduct of its affairs. (Up for vote to permanently remove from the Bv-Laws)

### Article III: Board of Directors

Section 1. Number and Authority. The business and property of this corporation shall be managed and controlled by a board of directors. The board of directors shall consist of the president, vice-president, and 8 elected members. In addition, if there is a county women's Promotion and Education committee and/or a county young farmers committee, the chairman of each shall be an ex-officio member of the board of directors with voting powers. The term of the elected official will be 3 years.

Section 7. Authorization of Community Organizations. For the purposes of local organization and representation, and in lieu of township organizations in the county as herein provided, the board of directors shall have the authority to duly designate throughout the county, community organizations including one or more contiguous townships or parts thereof in each community. (Up for a vote to permanently remove from the By-Laws)

Section 1. Appointment. The president and vice-president together with the secretary and one other person who shall be designated by the board of directors from among its number, shall constitute an executive committee. The term of office of the designated member shall be one year or until his-their successor has been appointed and accepted.

Section 5. Secretary. The secretary shall keep minutes of the meetings of members, of the board of directors and of the executive committee. He or she shall attend to the giving of all notices required to be given. In addition, he or she shall perform all duties incident to the office of secretary, subject to the control of the board of directors. Section 6. Treasurer. The treasurer shall keep a full and accurate account of the receipts and disbursements and deposit all money, checks and other obligations to the credit of this corporation in such depository or depositories as may be designated by the board of directors; shall disburse the funds of this corporation as ordered by the board of directors, taking proper vouchers for such disbursements; shall render a statement of account and transactions whenever required by the board of directors and shall make a complete annual statement before each annual meeting, which shall be verified by audit as directed by the board of directors; and generally shall perform all duties incident to the position of treasurer, subject to the control of the board of directors. The treasurer shall furnish a bond conditioned for the faithful accounting of funds and property in his or her custody in such amount as may be fixed by the board of directors. The premium on such bond shall be paid by this corporation.

Section 2. Order of Business. The order of Business at all meetings, insofar as possible, shall be as follows: a. Call to Order

- b. Roll Call Election and Appointments
- c. Reading of the Minutes Announcements
- d. Report of the Secretary Additions to the Agenda
- e. Report of the Treasurer Approval of the Minutes

Section 6. Disgualification. The holder of federal or state elected office, which office carries with it salaried compensation to the holder thereof, shall not be eligible as a candidate and shall not be qualified as an officer or director of this corporation, or voting delegate, in meetings of New York Farm Bureau, Inc. And In the event that any officer or director in this corporation, or voting delegate, becomes a candidate for such public office, he or she shall be deemed thereby immediately disqualified and his their term of office shall immediately and automatically terminate.

Section 9. TelephonicElectronic Participation. The Board, any committee of the Board, and any standing committee of the corporation may participate in the meeting by means of conference, telephone, electronic video screen, or similar communications equipment allowing persons participating in the meeting to hear each other at the same time and participate without limitation in all matters before the Board. Participation in the meeting by such means shall constitute presence in person at such meeting.
