Resolutions to be discussed and voted upon:

- 1 We are opposed to the closure or the reduction in service hours to the Herkimer County FSA office.
- 2 We support the extension of the Real Property Tax (RP-483) exemption for agricultural buildings.
- 3 We support the prohibition of the use of unmanned aerial vehicles (UAV) for hunting wildlife.
- 4 We oppose giving tax credits to insurance companies for investing in rural business growth funds.
- 5 We support alcoholic beverage producers be allowed to file their tax return electronically.
- 6 We support annual New York ingredient reporting requirements for farm brewery licensees.
- 7 We support individuals be granted additional Career and Technical Education (CTE) certification in any of the agricultural specialties if they have a certification in just one of the CTE Agricultural titles and pass the Agricultural Content Specialty Test.
- 8 We support the Farm Bureau create a national policy supporting the Agricultural Mediation Program.
- 9 We support the increased communication of the New York Farm Bureau with Congressional Representatives to push for a 2018 Farm Bill that will be more supportive of NYS agriculture and create a safety net for dairy farmers that actually works.

E-Lobby the Governor to sign a bill today to establish the inherent risk of equine and agritourism activities on farms.

Farms that invite the public onto their land are currently not well protected under the law. They don't want blanket immunity, but if they do everything right, and someone doesn't follow the rules and gets hurt, the farm can be sued. It can cost farmers tens of thousands of dollars just to defend themselves. This prevents many farms from opening their doors.
