2017 Chautauqua County Farm Bureau proposed By-Law amendment

A by-law amendment of Article VI Finance and Commercial Activities Section 2. Books of Account and Audit is being suggested to the membership of Chautauqua County Farm Bureau.

The change eliminates the need to have an annual audit conducted by a CPA and substitutes this requirement with a requirement to have an annual peer review.

This involves changing Section 2 by deleting the words, "Such books and records shall be audited at least annually by a Certified Public Accountant to be selected by the Board of Directors." This wording shall be replaced with "A peer review shall be conducted of such books and records at least annually. The peer group performing the audit is to be selected by the Board of Directors."
