

Proposed 2021 Policies

Essex County Farm Bureau is recommending the following policy proposals for 2021. Additional policy can be brought to the County Annual Meeting. While not required, please email Field Advisor Kim Trombly (ktrombly@nyfb.org), with your policy proposal prior to the meeting.

State

Agricultural Issues/Department of Agriculture and Markets

- We support New York State establishing a low-interest revolving loan fund for capital improvement on farms.

Economic Issues/ Energy/Renewable Energy

- We support increased educational resources for towns and other municipalities to aid them in developing solar and other renewable energy regulations.
- We encourage dual agricultural use solar.

National

Section 4/ USDA: Programs and Services/ 455- Agricultural Reports

- We support USDA having better price collection and price series information on specialty crops. This could be accomplished by adding prices to monthly agricultural data collection.

Section 4/ USDA: Programs and Services/ 464- Supplemental Nutrition Assistance Program

- We believe farmers should be given assistance to help facilitate online SNAP.

Proposed Bylaw Changes

The Essex County Farm Bureau Board of Directors is recommending the following changes to our county Farm Bureau bylaws. The proposed changes will improve communication within the board of directors, both during and in between meetings.

Article III: Board of Directors

Section 4. Notice of Meetings. Notice of meetings of the board shall be deemed to be duly given if notice thereof has been either mailed or sent electronically to each director, at the email address they have supplied for such purpose, prior to such meeting. Directors may waive such notice either before or after such meeting. Such waiver can be written or electronic.

Section 5. Electronic Participation. The board, any committee of the board, and any committee of the corporation may participate in the meeting by means of conference, telephone, electronic video screen, or similar communications equipment allowing persons participating in the meeting to hear each other at the same time, and participate without limitation in all matters before the board. Participation in the meeting by such means shall constitute presence in person at such meeting.

Section 6. Action without Meeting. Any action required or permitted to be taken at any meeting of the board, any committee of the board, or any committee of the corporation may be taken without a meeting if all persons entitled to vote at such meeting consent thereto. Such consent may be written or electronic, and such consent is filed with the minutes documenting such action.

Sections will be renumbered accordingly.

Adirondack Food Policy Council



Farmers and food systems advocates are creating a food policy council for the Adirondack region. A working group made up of local organizations, farmers and businesses is currently discussing structure, organization and focus of the group, and we want your input.

In general, food policy councils function as a food system planning venue and "department of food". They bring together members from government, academia, agriculture, food banks, restaurants, retailers and faith communities. They focus on health, planning, economic development, education, agriculture and social services. They conduct local food system assessments and they serve as the voice of the community related to food.
