

Statement on Inherent Risk Reform Bill Signing

A Huge Win For New York Farm Bureau

The governor’s signature delivers a major priority for New York farms that are looking to access legal protections and reduce liability insurance costs for agritourism and equine businesses.

New York Farm Bureau achieved a major victory for farms across the state with the passage and signing of inherent risk reform for agritourism and equine businesses (S.1152/A.559). Governor Andrew Cuomo signed the legislation that will amend the general obligations law to clarify responsibilities for both farm operators and visitors alike.

This legislation establishes limited liability protections for the inherent risks of inviting the public onto a farming operation. Agricultural tourism and outdoor recreation activities that include horseback riding, u-pick Christmas trees and fruit orchards, along with tours of wineries and maple operations, all now have a new line of defense against frivolous lawsuits because of the new law. Until now, New York’s litigious environment had diminished the number of insurance carriers willing to cover these businesses, while dramatically increasing the cost of liability coverage. Many farmers have had to turn down opportunities to invite the public onto their farm because they could not find or afford the liability insurance

necessary to host these opportunities in this state.

Under the legislation, farms must have proper signage to delineate pathways and buildings open to the public, adequately train employees involved in agritourism, take reasonable care to prevent foreseeable risks and post warnings to visitors about inherent risks of participating in activities on working farms.

The new law does not give New York farms blanket immunity from responsibility. Instead, it will protect owners from lawsuits by an individual who is taking no responsibility for his or her own actions. Farmers should not be at fault for a lack of due care by customers engaging in inherently risky activities or situations over which the farmer has no control. For example, customers should assume that there is some natural, inherent risk for riding a horse or climbing an apple tree and act accordingly to avoid injury.

“This legislation has been one of our organization’s major priorities. For too long, farmers had to choose between higher insurance costs or closing off their businesses to the general public that is eager to experience life outdoors on a farm. Now that we have crossed the finish line, we are hopeful business costs will reflect the reduced liability our farmers now have. New York Farm Bureau is grateful to Governor Cuomo for signing the important legislation that brings New York law in line with most other states. We also appreciate the leadership of both sponsors of the bill, Sen. Robert Ort and Assemblywoman Carrie Woerner, who have long championed the legislation. We are grateful as well for the effort of our members who made phone calls, e-lobbied their representatives, and spoke up about the need for this legislation. Their hard work made all the difference,” said David Fisher, New York Farm Bureau President.

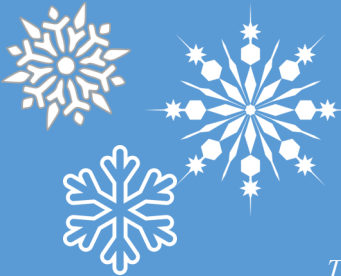

New York Farm Bureau Sets 2018 Priority Issues

Listed below are some of the priority issues recently announced by New York Farm Bureau for 2018.

State Priorities

- * Support funding for critical food safety, animal health and agricultural promotion and economic development programs in the Agriculture and Markets budget.
- * Double the minimum wage tax credit for farmers starting in 2018.
- * Support for funding of Environmental Protection Fund programs that provide cost-sharing of critical farm water quality and farmland protection projects that allow farms to reinvest in their farm business.
- * Oppose unworkable farm labor mandates and make much needed updates and reforms to New York State labor laws and regulations.
- * Transfer farm tax assessment functions from the Department of Taxation and Finance to the Department of Agriculture and Markets.

Criteria for determining what earmarks them for a priority is as follows:

- ◆ Issue must have a broad-based agriculture impact.
- ◆ Issue must be of significant interest to county Farm Bureau.
- ◆ Issue must impact farmers’ ability to conduct business, make a profit, or effect quality of rural living.
- ◆ Issue should attract member interest in anticipation of drawing their active participation.
- ◆ Issue should have a reasonable chance of being resolved.

2018 Tractor Safety Course in Ontario County

Cornell Cooperative Extension of Ontario County’s 4-H Program is once again sponsoring the Tractor Safety and Certification program beginning on Thurs., Jan. 25, 2018. This eight week series of classes is for youth ages 14 and 15 to meet the certification requirement of the US Department of Labor National Safe Tractor and Machinery Operations law. Youth ages 14 and 15 seeking employment on farms this coming summer will need this certification. Older participants may sign up if space allows.



Ontario County 4-H only offers this course **once** a year to youth in Ontario and surrounding counties. The 2018 classes begin on Jan. 25 and will be held on Thursday nights through Mar. 22 beginning at 7 p.m. at the Cornell Cooperative Extension office in Canandaigua. The driving test will be Saturday, Mar. 24. Classes are taught by volunteers with many years of practical experience as well as local farm equipment shop owners and employees. Tours of local equipment dealers, Monroe Tractor and LandPro and American Equipment, are included in the series of meetings.

Attendance at all classes is mandatory to receive the certification along with a written exam and driving test. The cost for Ontario County residents to take the certification series is \$25 and out-of-county residents is \$35. Employers are encouraged to have potential employees attend for the certification requirement.

The first meeting on Jan. 25 will be a presentation from the New York Center for Agricultural Medicine and Health of Cooperstown. The public is welcome to attend this event to learn more about farm safety and prevention across the state.
