## 2019 Proposed Resolutions

Below is a list of some of the resolutions that will be discussed at the annual meeting in September. If you have any proposed resolutions that you would like to present from the floor at the County Annual Meeting, please have them written beforehand. This will ensure the meeting will run more smoothly.

1. We support allowing e-WIC cards to be used at farmers' markets in New York State.
2. Should the quarterly employer payroll threshold for unemployment insurance for agricultural labor be increased from \$20,000? If so, what should it be increased to?
3. We support a two-year moratorium on requiring CAFOs to install manure lagoons because of the difficulty in finding financing for construction to gain compliance.
4. We support increasing the state's cost sharing program for CAFO manure lagoons from \$385,000 to \$750,000.
