### President's Message



I wanted to let you know the importance of Farm Bureau's efforts when working to oppose the Farmworker Fair Labor Practices Act. We had the cards stacked against us when this bill was introduced with Democratic majorities now in both the State Senate and Assembly.

There were enough votes to pass the bill when it contained a 40-hour week and eight-hour day overtime threshold and collective bargaining that would allow for worker strikes.

With all the efforts of Farm Bureau and other agricultural organizations, we ended up with the best deal we could at this time with the situation that we faced in Albany. In the end, the act that passed includes a 60-hour overtime threshold and collective bargaining with an anti-strike clause. This middle ground is much better than at the start and Farm Bureau had an important role achieving these compromises.

There are still many concerns with this bill, especially the wage board that will start next year to consider lowering the threshold below 60 hours. We will basically have to repeat this year's efforts again next year to keep this from happening.

I also wanted to let you know that Farm Bureau members voted at the State Annual Meeting last December to increase the membership dues this year. The dues will now be \$99 if you pay before Nov. 1 and \$110 if you pay after that time. It has been 12 years since a dues rate increase and the time had come for this change.

We need to continue to stand together with all of agriculture to support one another.

#### Young Farmers and Ranchers 18 - 35 years old

"For the past four years, Darin and I have served as the District 1 representatives for the New York Farm Bureau's Young Farmers & Ranchers Committee. It has been challenging as well as rewarding, but the most we will take away from it is all the friendships we have made along the way.

Most young farmers when approached for this position say, "I don't have the time". That was a huge concern of ours when joining, as we have kids and a dairy farm, but as we started our first year, we learned everyone on the committee has the same issues. As we went to the meetings and got to know more people, we learned that If you can't make it to a meeting that is a distance away, it's not the end of the world. These people understand that. There is typically a face-to-face meeting in January, then the Young Farmers & Ranchers Leadership Conference in February or March, a summer meeting in a different district each year, and the State Annual Meeting in December. Believe me, we have not made it to all of these each year. We have been to each one, but not all in the same year. It is too much time to be away from your family and farm. There are conference calls throughout the year as well, and we have been on most of them because they are easy and it's important to let the committee know you are involved and have an opinion. Keep in mind that when and if you go to all these face-to-face meetings, you are reimbursed for your travel and lodging expenses as well as your food, so you're not out any money, just time. For us, we saw it as an opportunity to get away for a minute from our busy lives and see other people that have the same interest as us and share some of the same struggles. Don't let the meeting times scare you, make it to what you can and be involved in other ways.

Please consider being a part of this great committee. You can do it as an individual or a couple. If you have any questions, please don't ever hesitate to call or email me. Our term is up at State Annual Meeting in December and we hope that someone from our district will fill the next two-year term."
