

Attention High School Seniors! It's Scholarship Time!

March 1st, 2022 deadline

The NYFB scholarship application is currently available at NYFB.org. Applicants will compete to win a \$250 renewable scholarship from Cattaraugus County Farm Bureau, a \$250 district level award, and on the state level, district winners will compete for a \$2000 and \$3000 award.

Applicants must be 2022 graduating High School Seniors who will continue their education to prepare for a career in some way connected to the diverse agricultural industry. This includes advancing their education through college or pursuing advanced training in the skilled trades.

Applicants must also live or work on a farm or be involved with agriculture via any avenue.

Applicants must have a Family Farm Bureau membership or Student Farm Bureau membership. Students can join as a Student member by visiting www.nyfb.org/membership. Student membership is complimentary.

Applicants under the age of 18 must also include the signature of a parent or legal guardian.

Students are required to complete the application which is on the Reviewr on-line platform.

After creating an account in Reviewr, the student can log in and begin the application. The student can stop, restart, and edit their application any time before the submission is due by logging into their Reviewr account.

Applications must be completed and submitted by 5:00 pm on March 1, 2022.

Cattaraugus County Farm Bureau Wins Awards at State Level

Even though the State Annual Meeting for New York Farm Bureau (NYFB) was an abbreviated affair with only voting delegates from each county allowed to attend, NYFB still gave out their annual awards.

Cattaraugus County Farm Bureau (CCFB) had a tremendous showing this year. While we usually win most of the county excellence awards in the various categories (membership, policy development, media relations, etc) this year we also won the coveted Gold Key Award. This is the only the second time that CCFB has won a Gold Key, with the previous time being in December of 2017.

In addition to the Gold Key, Cattaraugus County also received the 2021 Promotion and Education Award, thanks to our Pro-Ed chair, Katie Hill. Katie's tireless work managed to save our annual Ag- Literacy program by developing a COVID friendly version that engaged students, and in some ways, offered advantages over the traditional way. The Variety Pack 4-H Club members were recorded reading the book Tales of a Dairy Godmother, Chuck's Ice Cream Wish. In addition, Katie made an 18 minute video tour of her family's dairy, Hill's Valley Farm. Each class was supplied with a book and kit to make their own ice cream in a bag from Ag in the Classroom. Upstate Niagara donated the half and half required to use those kits. Each classroom also received a Farm Bingo game and students were invited to write letters or emails to Hills Valley Farm with any questions they had regarding the video. Some great examples are shown below. Overall CCFB Pro-Ed reached 954 kids and teachers with last year's Ag Literacy Project. Great job to all those that helped out!





CCFB Planning for 2022

Cattaraugus County Farm Bureau is looking to keep as many activities as possible on the calendar for 2022 despite the uncertainty that the continuing COVID pandemic has placed over everything. We are planning to have our annual visit to the County Legislature in mid February. As more 4-H and FFA trips are being offered, perhaps you find yourself in need of a little extra cash to help fund your excursion. Maybe you're a member of the FFA that would like to attend the summer camp. Perhaps you would like to try a new livestock project in 4-H this year and need a little cash to fund the building of a new pen? We can help!

Over the past several years the Cattaraugus Farm Bureau has held an ag trivia fund raiser to make money for just these type of circumstances! We would like to help out the youth in our county to achieve their agricultural goals. We are willing to award up to \$200 per youth that applies until the money runs out.

The application requires your basic information, plus whatever farm/ agricultural experience you have and a 300-500 word essay. The essay must include what you want to use the money for, what do you expect to gain from the experience, who sponsors the trip or activity, and what is your total cost for this trip or activity. In addition you will need to include your involvement in agricultural, school, and community activities. You must have a Family or student Cattaraugus County Farm Bureau Membership or be sponsored by a Cattaraugus County Farm Bureau member. All 4-Hers and FFA students are welcome to apply.
