### **Agricultural Non-Point Source Pollution and Abatement Program**

This program supports farm water quality projects such as AEM and CAFO compliance. Additional funding is needed to help farmers comply with costly water quality regulations, especially to meet federally mandated TMDL requirements in the Chesapeake Bay Watershed counties.

### **Agricultural IPM**

A broad-based approach that integrates practices for economic control of pests. IPM aims to suppress pest populations below the economic injury level (EIL).

# Governor's Fiscal Year 2022-2023 Executive Budget Article VII Legislation

# TRANSPORTATION, ECONOMIC DEVELOPMENT AND ENVIRONMENTAL CONSERVATION (TED)

### IMPLEMENTATION OF CLEAN WATER, CLEAN AIR AND GREEN JOBS ENVIRONMENTAL BOND ACT

### Part NN and Part 00

Amends the former "Restore Mother Nature Bond Act" to rename it to the Clean Water, Clean Air and Green Job Environmental Bond Act of 2022 and adds an additional \$1 Billion the amount of general obligations bonds to \$4 billion.

## IMPROVEMENTS TO THE FRESHWATER WETLANDS REGULATORY PROGRAM Part QQ

Would allow DEC to regulate wetlands smaller than the current 12.5 acres if the wetland is of "unusual importance."

**NYFB Opposes** 

### **EXTENDED PRODUCER RESPONSIBILITY**

#### Part RR

This legislation would create an Extended Producer Responsibility program for packaging putting the responsibility for the recycling system on the producers of products covered. The legislation would establish producer responsibility organizations. The legislation would additionally create a fund to receive revenues from producers for DEC to administer and enforce the program. producer responsibility programs will be valid for 5 years and reviewed and updated every 5 years.

## TRANSFER THE NATIONAL SCHOOL LUNCH PROGRAM FROM THE STATE DEPARTMENT OF EDUCATION TO THE DEPARTMENT OF AGRICULTURE AND MARKETS

#### Part V

Amends the Agriculture and Markets law regarding the Department of Agriculture and Markets authorization to administer the farm to school program to further include the National School Lunch Act and related food programs, including the 30% Farm-to-School initiative.

### **ARTICLE VII**



## ADVANCED BUILDING CODES, APPLIANCE AND EQUIPMENT EFFICIENCY STANDARDS, AND THE BUILDING BENCHMARKING ACT OF 2022

#### Part EEE

Amends the building energy for buildings in the construction of residential, commercial, rehabilitation of existing buildings and agricultural buildings through the heating, cooling, ventilation, lighting and insultation and design techniques to achieve energy savings greater than current International Energy Conservation Code and to meet the goals of the Climate Leadership and Community Protection Act (CLCPA). New buildings would be required to have zero onsite greenhouse gas emissions no later than 2027. This bill also would also amend energy/efficiency standards for appliances and equipment.

#### **NYFB Opposes**

### **NATURAL GAS SERVICE**

#### PART CCC

This proposal would authorize the Public Service Commission (PSC) to disallow gas corporation form covering the cost of the first 100 feet of infrastructure between a natural gas main and gas meter, thereby increasing the cost to the building developer and discouraging them from choosing natural gas over other alternative, cleaner fuel sources.

### **REVENUE**

#### **ENHANCES TAX CREDITS FOR FARMERS**

### Part B - Subpart A

This bill would amend the Tax Law to enhance the investment tax credit (ITC). Currently, the ITC is equal to four percent of the investment credit base under the personal income tax or 5 percent of the first \$350 million of the investment credit base and four percent of the investment credit base more than \$350 million under the corporate franchise tax.

This subpart would increase the credit under both taxes to 20 percent of the investment credit base for eligible farmers for property principally used by the farmer in production of goods by farming, agriculture, horticulture, floriculture, or viticulture.

### **DOUBLES FARM WORKFORCE TAX CREDIT**

#### Part B- Subpart B

Doubles the per employee amount for the farm workforce retention credit. This credit would start for the 2021 tax year and be extended through 2025.

### **ARTICLE VII**

#### FARM EMPLOYER OVERTIME TAX CREDIT

### Part B - Subpart C

Creates a refundable tax credit for overtime wages between 40 and 60 hours of work per week. Eligible farms are corporations, sole proprietor, partnerships, or LLC.

### **EXPAND SMALL BUSINESS TAX RELIEF**

#### Part C

This bill would expand the small business tax relief subtraction modification for taxable years starting January 1, 2022. This would increase the small business subtraction modification for taxpayers from 5 to 15 percent of the net business or net farm income included in the taxpayer's federal AGI. Under current law, a small business is a sole proprietorship, and in the case of a farm business, also a partnership, LLC or S corporation, that employs one or more persons and has a net business or farm income of less than \$250,000. This bill would expand the definition of a small business to include LLC's, partnerships or S corporations that are not farm businesses that employ more than one person and have a New York AGI of less than \$1.5 million.

### **CREATES A TAX CREDIT FOR SMALL BUSINESS COVID-19 EXPENSES**

### Part E

The bill creates a refundable tax credit available to small businesses with \$2.5 million or less of gross receipts that incurred qualifying COVID-19 capital costs from January 1, 2021 through December 31, 2022, to comply with public health or other emergency orders or regulations related to the pandemic or to generally increase the safety of their business locations as it relates to disease mitigation, including social distancing, sanitization and air purification. A small business would be eligible for a credit of 50 percent of qualifying costs, up to \$25,000. Program capped at \$250 million.

### **TEMPORARY RETAIL PERMITS EXTENDER**

#### Part M

This bill would extend the ABC law provision allowing the State Liquor Authority to issue temporary permits to retail applicants while the full review of their license application is going on.

### ALLOW FOR THE SALE OF TO-GO DRINKS

#### Part P

This bill would allow the permanent sale of alcoholic beverages to go for off premise consumption. Any retail license that allows for liquor and/or wine sale for on-premises consumption also would include the privilege **NYFB Supports**


