State Legislative Update... Farmers from across the state have traveled to Albany in early March for New York Farm Bureau's annual Lobby Day. Seneca County Farm Bureau was there to advocate on behalf of all of our members. Here is a sample of what we talked about:

A refundable tax credit for farmers; Doubling the minimum wage tax credit for farmers, from \$30 million to \$60 million; securing finding for critical farm programs, including EPF, ag education, FFA, infrastructure, research, technical assistance; a procurement preference for New York grown food for state institutional purchasing; state tax credit for donation of locally grown food by farmers to food banks.

You don't have to travel to Albany to advocate on behalf of agriculture. The New York Farm Bureau website, nyfb.org, has made it easy to contact your legislators to ensure they know your opinion on important issues that affect your farm, your business and your food supply. Here you will find a host of issues and easy ways to help influence the way government responds toward agriculture. It has been a difficult couple of years, from low commodity prices, minimum wage hikes, excessive taxes to severe overregulation and rising input costs. We need to ensure our government is investing in you and for future generations to come.

Promotion and Education Update

The Seneca County Farm Bureau Promotion and Education committee met on Friday, February 18 to discuss this years projects. The *Why I Farm* series of articles were a big winner last year and we hope to have Fred Jensen working with other counties in the coming months to broaden their reach. Tara Lott will continue working with local libraries and seed companies on commodity brochures and seed displays. 
