NYFB National Affairs Director Lauren Williams testified before the U.S. House Rules Committee yesterday in Washington on the need for federal right to repair legislation. This would give farmers additional options to



repair technologically advanced farm machinery rather than be dependent on the equipment manufacturers, expediting repairs and saving farms money. Rep. Joe Morrell introduced federal right to repair legislation (Fair Repair Act, H.R. 4006) that NYFB is supporting.
