Recently the Albany County Farm Bureau board partnered with the Eastern New York Farm Bureau Regional Office for a variety of services. One of the services is to produce newsletters, and I am pleased to introduce the first edition to you.

As such, this first newsletter has a focus on upcoming policy development issues and is seeking your thoughts, ideas and concerns surrounding your life and business in agriculture.

Some of the current issues under discussion include:

- Eligibility of farm operations under seven acres for agricultural assessments;
- Extension of Real Property Tax (RP-483) exemption for agricultural buildings
- Prohibition of the use of unmanned aerial vehicles (UAV) for hunting wildlife in NYS

In this newsletter, you will find further information about current issues of concern. As Farm Bureau members, it's up to us to bring these issues to our County Annual Meeting in October for consideration. More information on date will be in future mailings. Policy Development Questions:

Please review these topics and bring this to your county policy development meeting and County Annual Meeting this summer and fall as a jumping off point for discussion in your county. As always, members are strongly encouraged to bring unique ideas/suggestions to your county Farm Bureau board of directors. and plan to develop policy specific to the needs in your county.

State Policy Items:

1. Should farm operations of less than seven acres used in agricultural production be able to generate less than the current \$50,000 in annual gross sales income to be eligible for agricultural assessment?
2. Should the Real Property Tax (RP-483) exemption for agricultural buildings be extended?
3. Should New York prohibit the use of unmanned aerial vehicles (UAV) for hunting wildlife?
4. Should there be a tax credit or other incentive for carbon farming?
5. Should New York allow insurance corporations to receive a tax credit for investing in rural business growth funds and to establish a fund for investment in agriculture and enterprises that create jobs in rural areas?
6. Should providing shelter be included and defined in the animal cruelty statute?
7. Should a standard be set in law for "pollinator-friendly solar arrays"?
8. Should alcoholic beverage producers be able to electronically file their tax returns?
9. Should koji-based distilled spirits be defined under Alcoholic Beverage Control Law and eligible for sale at retail for consumption at locations licensed to sell wine?
10. Should there be annual New York ingredients reporting requirements for farm brewery licensees?
