### **Oneida County Farm Bureau Proposed Policy Resolutions**

#### **State Policies**

- 1. We support agricultural assessment on all acreage used by any farm operation exceeding \$10,000 \$50,000 in sales. (Current policy #19 on page 2 in section on Agricultural Assessments, new language in bold and underlined)
- 2. We support extending the 10-year Real Property Tax Exemption (RP-483) for newly constructed or reconstructed agricultural structures.
- 3. We support prohibiting the use of unmanned aerial vehicles (UVA'S) for the hunting of wildlife
- 4. We oppose the creation of a tax credit program for insurance companies to invest in rural business growth funds as it has proven unsuccessful in other states.
- 5. We support ensuring that farm brewery licensees comply with the provisions to use New York State grown products, as noted in the existing statute <u>and further support the development of an on-line annual compliance/audit report for the licensees to complete that ensures that the provisions of the statute are <u>being met.</u> (Current policy #15 on page 39 in the section on Brewery and Distillery Issues, new language in bold and underlined)</u>
- 6. We support allowing producers of alcoholic beverages to file their annual New York State tax returns electronically similar to all other businesses in the state.
- 7. We support allowing koji-based distilled spirits being defined under the NYS Alcoholic Beverage Control Law and being allowed to be eligible for sale at retail for consumption at locations that are currently licensed to sell wine.
- 8. We support the definition of shelter as adequate protection from the elements and weather conditions suitable for the age, species, and physical condition of the animal so as to maintain the animal in a state of good health, as determined by the state veterinarian. Shelter for livestock includes structures or natural features such as trees or topography and does not necessarily require a barn or other structure to be in place.
- 9. We support the inclusion of crossbows as legal implements for all hunting seasons. (Re-affirmation of current policy #11 on pg. 107 in the section on Hunting Issues)
- 10. We support the establishment of agriculture education teacher certification programs at Cornell College of Agriculture and Life Sciences and SUNY schools. (Re-affirmation of current policy #11 on pg. 120 in the section on Post-Secondary Agricultural Education)
- 11. We support increasing state school lunch reimbursement for purchase of locally produced fruits and vegetables. (Re-affirmation of current policy #9 on pg. 122 in the section on School Meals Program)
- 12. We support creating a dedicated New York State fund to assist schools in purchasing New York grown products such as fruits, vegetables, milk and other dairy products along with other New York grown foods for use in the school lunch system.
- 13. We continue to support increased funding in the state budget for the Agricultural Education Outreach Program housed at Cornell University, which coordinates Pre-K through grade 12 agricultural education through Ag in the Classroom, FFA, and professional support to the New York Association of Agricultural Educators (NYAAE). (Re-affirmation of current policy #1 on pg. 118 in the section on High School Agricultural Education)

#### **National Policies**

1. We oppose requiring all aspects of the CNMP (Comprehensive Nutrient Management Plan) being completed to receive EQUIP funding, only those practices that are part of the EQUIP funding should have to be completed.
